Other than normal lodge DDGER visits a great deal of my time was spent working with lodges on FRS and Tax reporting issues.

It is that time of year for the lodges to prepare all of the required documents for the preparation of taxes for lodge year 2023-24. It should be noted the changes made to the reporting of UBI. The tax rate is now 21% with a \$1,000.00 deductible. The most important change affects how you file. If the amount owed exceeds \$500.00 the lodge will be required to file quarterly using electronic filing. If you have exceeded the \$500.00 this past year and have not filed quarterly you will most likely be accessed penalties and interest. It should be noted before the lodge taxes can be uploaded to Grand Lodge they must be submitted to the DDGER along with the lodge balance sheet used for preparation of the taxes. Those documents along with the FRS report will be reviewed for matching numbers. Only after all numbers match are the taxes to be uploaded. A new upload will, be required to FRS system to handle any adjustments your accountant may have recommended during the preparation of the lodge taxes. Failure to do this will cause your upload to be flagged "Pending" and the sponsors will be notified.

It is extremely important for the lodges renting their facilities to separate the rental agreement from the food and beverage service agreement to help prevent the lodge being charged UBI taxes on the total of the rental. The increase in UBIT should taken into account when setting prices for hall rentals. Once again, I point out the importance of reporting and paying Use Tax on goods purchased outside the state without sales tax being charged and using the goods in the Nevada. A prime example of this is material purchased from Grand Lodge – all require use tax to be paid. As with the IRS the first thing the State Franchise Tax Board looks for is unpaid Use Tax. It is almost guaranteed something will be found in both cases giving cause for further digging.

SUBJECT: Year-End Report of the Nevada State Ritualistic Committee

The following is the Year End Report of the Nevada State Ritualistic Committee.

At the Midterm Convention in Carson City, I reported on the State Ritual Clinic in Tonopah on October 21, 2023, during which six of our Judges (Bill Bohnett and Ross Dyer from North Las Vegas, Gene Presnell and Jackie Edwards from Hawthorne, Dee Boskie and Frank Reynolds III from Reno) performed the Initiatory Ritual along with Loyal Knight Rachel Drake from Reno playing Loyal Knight and Candidate Marnie Frank from Reno playing Candidate. All in all, it was a very successful performance, that is with a totally unrehearsed cast, performing togetherfor the first time ever, I videotaped the performance in its entirety. One thing that became immediately clear to me is that I needed a second camera to show the entire field of play, to catch the unison moves by the entire team. During post-production, I did do some minor editing in my home studio, primarily for continuity and sound, but no content was altered in any way. shape or form. The purpose behind the videotaping was two-fold-one, to hopefully use it for the re-qualification of our Judges, two, for the training of any Lodge which doesn't have the luxury, like the Reno Lodge does, of having five regular Ritual Coaches. I sent the finished video to our Area 7 Ritualistic Committeeman for his approval for me to use the video for those two stated purposes. Happily, he said, "OK", provided that it be used only for those two purposes and no other.

After viewing that video over and over again, it became obvious to me that, "warts and all", it needed to be redone—my intended goal for this year as State Ritualistic Chairman, which incoming President Ross Dyer has asked me to take on. Stay tuned. Reno Officers, keep doing

During the year of 2023, the United States of America had 112,000 deaths due to opioid overdose. This figure is increasing every year. Fentanyl is the leading cause of those deaths.

It is more deadly than Heroin and Cocaine.

I was invited to attend the 2023 Opioid Youth Summit in September. Clark County School District Counselors picked 1000 at risk children to attend the summit. The information was very informative. It is hoped that the children who attended will tell their friends and family about the dangers of drug use.

I will encourage all Drug Awareness people from all Nevada Lodges to put forth more effort to contact schools and organizations to discuss the dangers of drug use.

Update on the Drug trailer for the South. Mesquite Lodge # 2811 has sold a trailer to NSEA for \$1.00. I will have the trailer registered. I will be getting estimates for decals or wrapping the trailer and present that cost soon. I will keep the trailer at my house in Ely so it will be out of the sun to preserve the signage. It will also be safer in my yard. When lodges request the trailer, I will meet them halfway or they can pick it up in Ely.

For this annual meeting report, there were 17 activities with 124 Elks, 383 non-Elks, totaling 641 Elk hours, 951 non-Elk hours, 2316 Elk miles, 2356 non-Elk miles, 3542 people reached, 1723 pieces of materials distributed. Elroy was used 5 times. 30 Public Relations articles submitted.

NSEA Public Relations State Report

NSEA President Frank Reynolds III,

Public Relations is still a focus in many lodges. I want to give a special thanks to those public relations lodge chairs who stepped up, by not only getting their reports into me in a timely manner, but submitting articles to the media. Most lodges had 100% reporting, all year long, with a few not being quite there. There's still more that can be done in getting those numbers improved, but it's a work in progress that I am addressing with each public relations chair in an attempt to have 100% reporting EVERY month. I hope to see media reporting improve by certain lodges going forward. In addition to simplifying the form last year, I've done my utmost in helping each chair to reach that goal.

The public relations chairs throughout the State have submitted, since April 1st -2023 until March 31st, 2024, 3,031 news articles which was much better than last year. Also the Elks have been represented on TV 28 times and 287 times on the radio, which is on par from last year's total. There were a total of 1,124 Elks signs prominently displayed in the community. There have been 2,638 e-mails, lodge website and Facebook posts promoting the Elks, which has decreased from last year's total for the year. I anticipate those figures improving by next year due to training. Our State also had 14,395 other types of situations promoting the Elks not described in the prior categories. While there were some situations being overlooked by the chairs at the beginning of this reporting year, due to lack of experience, I continue to advise each chair on how they can improve on their totals. Thus far, I have seen an improvement on those numbers. Public relations chair members have volunteered 3,238 hours and drove 9,269 miles to achieve this accomplishment. Both these figures are higher than last year due to training. All in all, as a group we did a really good job communicating the events we've held in our respective communities, towards the betterment, to the media.





Subject: NSEA Scholarship Annual Report

As an update to the 2024-25 Scholarship year, the State had participation from 14 lodges, with 232 total students applying for the ENF Most Valuable Student Scholarship.

Seventy-three (73) of these students advanced to the District levels and were graded by both our North and South District Chairs and their selected judges. The North Chair is Bob Haug of the Tahoe/Douglas Lodge and from the South, Kris Weiland of the Mesquite Lodge.

From the seventy-three (73), the top 35 advanced to the State level for judging. These students have been judged and the top seven (7) have been advanced to Grand Lodge for their judging.

Grand Lodge has completed their first round of judging and has announced the top 20 students in the nation. Unfortunately, the 7 students from Nevada did not make it to the top 20, but each have been awarded \$4,000 for a total of \$28,000.

We (NSEA) are waiting for funding from ENF to provide our own State awards to the 35 State finalist.

Just announced this week were the Grand Lodge Legacy awards where Nevada had four (4) students receive \$4,000 each for a total of \$16,000.

The State also awarded two (2) Vocational Scholarships for a total of \$4,000. We have a third applicant who we requested additional information to be considered for an award.

Again, I want to thank Bob & Kris for their support this past year. Also, all the District & State judges for their experience and taking the time to judge all these fine students. All combined, their hours exceeded 500 hours. As for the numbers, since the November Mid-Term meeting, I have contributed a total of 129 hours and 100 miles so far for this year.

Greetings to our President and first Lady, distinguished guests, members, and your spouses

My name is Bob Haug, ENF Fundraising Chair. This is my NSEA ENF Fundraising Chair Report from April 1,2023 to March 20,2024.

Volunteer Hours = 250. No Miles or expenses. I spent my volunteering hours meeting with the ENF Fundraising Manager monthly, discussing with Frank the expenditures and goals, and reviewing these also with each lodge Chair and reviewing the NV monthly fundraising reports. I discussed with each lodge ENF Fundraising Chair their progress towards meeting the ENF goals.

The Goals for each lodge are:

- to increase Funding over last year by 10%, Exceed \$4.80/ member (all lodges exceeded this goal),
- have at least 15% of membership donors join the Fidelity Club, and
- for the Lodge ENF chair to exceed their score by 550/1000 pts.

By Meeting each of these goals, their lodge would receive an additional \$500 for each Lodge which would total \$4,000 added Gratitude amounts for their all Lodges. The NV Detailed report prepared by ENF for the period 4/1/22 through 3/31/2024 is attached.

By giving to the ENF, you are doing more than funding the ELK's National Awareness and Hoop Shoot programs, you are doing more than supporting the Community Investments program and providing Scholarships for the MVS including emergency educational grants to children of deceased or disabled Elks, you are doing more than meeting the needs of today's veterans. You are doing all of that and you are supporting Elkdom in Nevada. During the 2022-2023 lodge year NV Elks donated \$145,636.50 to ENF (\$24.13/member — which was first in the nation). This



year so far you are exceeding these donations. I Congratulate each of you and lodge members for a job well done.

The ENF's budget for program services for the 2024-2025 fiscal year totals \$41.6 million. Which is proposed as follows:

- 1. Community Investments Program \$16.3 M
- 2. State Elks Association Grants \$11.2
- Million
- 3. Scholarship Programs -\$5 M
- 4. Elks National Veterans Service Program \$5.7 M
- 5. Elks Hoop Shoot Throw Contest- \$1.5M
- 6. Elks Memorial Building Maintenance-#IM
- 7. Elks Drug Awareness Program \$.9M

This year the Elks National Foundation gave to the Nevada State Elks Association:

- 1. State Charities Grant: \$89,700.00
- 2. Special Projects Grant: \$62,000.00
- Scholarships: 7 MVS \$28,000,00 Legacy \$16,000.00
- 4. VAVS Volunteers: \$ 6,000.00.

For a Grand Total of \$217,700.00. This is \$1.495 for each dollar donated by the Lodges of the Nevada State Elks Association, which was \$145,636.00. This does not include the dollars sent to the lodges totaling \$117.4K

I encourage each Lodge Chair to recognize and reward current donors and exceed last year's goals. Show your community that Elks Care.

Good morning,

President Frank, members all, this is my Membership Report for FY 2023-2024.

Overall, 2023-2024 was a fair year, membership wise. We had a NSEA membership increase of 376 new members. Our roles are now 6,883. Again, this appears to be great news. However, we have several issues that are cause for concern.

- We have an aging membership. The average age for most lodges is 63. We need to make an effort to find and initiate younger members of our communities. We lost 107 members to death.
- 2. We have six Lodges that initiated 10 new members or less. If you have candidates waiting to be initiated, you can have more than one initiation each month. Last year we left 210 candidates uninitiated.
- 3. Our greatest area of loss is in Delinquency Drops. If you sponsor a new member, keep in contact with them, invite them to a lodge meeting or event. Get them involved.
- Our increases as a whole were 5.8% increase. That was 10th in the nation. We were number one in the nation last year.

So again, overall, a fair year, but we have a lot of room for improvement. So, please hold events to get people to attend, hand out applications or instructions to apply online. Initiate, initiate, initiate. If you need help, contact Lodges that are having success and ask for ideas and help to increase membership and serve your communities.

This is my report for my hours, miles and expenditures from April, 2023 through April, 2024 as VAVS Rep. for the V. A. Hospital, Nevada South and as State Veterans Chair, also.

My volunteer hours are 269 My volunteer miles are 3,002 My expenses were \$1,134

From our Mesquite Lodge, their Veteran's Transport Van, transporting Vets to the V A Hospital here in North Las Vegas from Mesquite, Nevada with 5 drivers, spent 1,680 hours, 21,561 miles, assisting 303 Veterans to their medical appointments. A big thank you to the Mesquite Lodge.

I, also procured a \$6,000.00 grant from Grand Lodge on behalf of the North Las Vegas Elks Lodge 2353 for the Adopt A Vet Dental Program for low-income Vets, which provided 10 Veterans with full sets of dentures. The actual cost in the private sector of dental care would be approximately \$100,000.00 if it were not for the Adopt A Vet Dental Program.

I procured 100 baby blankets from the Las Vegas Quilting Guild for 100 Lady Vets giving birth this year at the V A Hospital. The blankets in the private sector would cost approximately \$15,000, however, they were free from the Las Vegas Quilting Guild.

All VAVS Reports have been submitted to Grand Lodge and were approved. I attended all VAVS meetings and VSO meeting at the V A Hospital.

I would like to thank Ted Balash for his services to the Reno V A Hospital and for sharing my quest to help lady Vets as he too purchased articles for a Baby Shower for 35 Lady Vets from the Reno V A Hospital in the amount of \$2,279. Good job Ted. Thank you to Tim Murray, the VAVS Rep to the Boulder City Veteran Convalescent Home for all he does out there. The North Las Vegas Emblem Club shared in my quest to also help vets at the home with 50 lap blankets, sundry products, also, giving cards, writing stationary, even stamps for the vets to communicate with friends and family members. Oh, I almost forgot the Teddy Bears. The vets just love Teddy Bears.

Outreach efforts have been successful in increasing awareness of The Hides to the program. As one of only eight (8) States that participate in the program, our numbers of hides donated are still well below the other States. This year, NDOW has proposed an increase in the number of tags to be issued after tag reductions in the last two hunting seasons. Hopefully we can use that increase to our advantage.

Activities in support of The Committee are as follows:

Continue to increase activity in hunting related groups, to bring awareness of the program to other hunters. Created our own Facebook page, Nevada Elks Hides Program, to connect to hunting and outdoor events posted by Nevada Dept of Wildlife and others.

Attendance at various hunting events to make others aware of the program.

Continue to attend New Member Orientation each month at The Reno Lodge, to make new members aware of the program, and explain how easy their involvement can be promoting the program to others.

On February 3, 2024, we held the first Wild Game Dinner held at the Reno Lodge to promote The Hides Program. We served more than eighty (80) Elk Burger dinners with wild game appetizers and sides.

Our next event is a Hunting Tag Gathering on Friday, May 17, 2024 at the Members Bar of The Reno Lodge, the same day NDOW will begin releasing the results of the Big Game Tag Draw.

We were successful in obtaining a half-page advertisement in the NDOW Big Game Seasons & Applications and Big Game Hunting Guide. See page 48 to view the ad.

I have been asked to speak at the next Mule Deer Foundation Dinner to explain to their members how the program works, and ask for their help.

The numbers of hides collected, and time and mileage are essentially unchanged since my November report. Our tannery in Tennessee that processed our hides has closed. Fortunately, The National Hides Chair has connected with an even larger tannery in New York State. The incoming National Hides Chair is scheduled to deliver hides there soon and meet with them personally.

Goals for the next year include another Wild Game Dinner, continued promotion of the program, and seek promotion in other NDOW materials and other publications.
