ARTICLES OF INCORPORATION OF NEVADA ELKS MAJOR PROJECT, INC (NEMPI)

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are veterans of the State of Nevada, have this day associated ourselves together for the purpose of forming a non-profit corporation for charitable and eleemosynary activities,

AND WE HEREBY CERTIFY:

I.

The name of said corporation is:

NEVADA ELKS MAJOR PROJECT, INC.

II.

That the purposes for which this corporation is organized are:

(1) To raise funds for assisting and aiding in the "Visual Screening of Children", to raise and expend money for such purposes and for the establishment and use of mobile units, staffs of trained therapist and others for help in such visual screening; but with the specific provisions that none of the funds raised shall inure to the benefit or profit of any individual person or persons. That funds shall be raised in such amounts and proportions, as may from time to time be determined by the corporation Board of Trustees, and to raise funds for a carrying on of such charitable and eleemosynary activities, either through Nevada Elks Association and/or its members, or from other organizations, sources, or individuals, and to do any and all things incidental or necessary thereto, expedient, useful or desirable in connection therewith, including entering into contracts, which this corporation may lawfully do in furtherance of any or all such purposes.

(2) This corporation is one that does not contemplate any pecuniary gain or profit to the members thereof. All funds raised by this corporation, with exception of such part thereof as may be required to meet the reasonable expense of maintaining this corporation and its relief, charitable, and welfare activities, shall be held for distribution and distributed, paid over or made available only for all or any of the purposes aforesaid. No part or portion of the net receipts, earnings, funds of this corporation, shall at any time inure to the benefit of any private member of this corporation, or other individual. The property of this corporation is irrevocably dedicated to charitable purposes, and upon liquidation, dissolution, or abandonment of the owner, after providing for the debts and obligations thereof, the remaining assets will not inure to the benefit of any private person but will be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code. (a) A resident of the State of Nevada; and

(b) A member in good standing of an Elks Lodge in Nevada which holds current membership in the Nevada State Elks Association.

VI.

The duly elected or appointed Board of Trustees shall have the power and authority to elect or appoint officers of the board, ie. president, secretary and treasurer.

If a member of the Board of Trustees shall fail to apply himself diligently to the purpose of the corporation or shall cease for other reasons, to be qualified, the Board of Trustees shall terminate his term, declare a vacancy, and may with the approval of the Board of Trustees of the Nevada State Elks Association, fill such vacancy with a qualified person to fill the unexpired term of the vacancy.

VII.

There is hereby delegated to the corporate Board of Trustees the power to make, amend or repeal By-Laws, subject however, to the approval of the Board of Trustee of the Nevada State Elks Association.
