
Nevada Veterans Recognition

COMMITTEES AND THEIR DUTIES

Auditing Committee: The Auditing & Accounting Committee shall be charged with making all arrangements for completion and submission of the Lodge's Annual Financial Report to Grand Lodge and all required governmental agencies by June 15th for all entities of the Lodge whose fiscal year ends March 31st. Review the year-to-date financial affairs and compliance with the approved budget of the Lodge in the months of July, October and January, and report at the last regular meeting of those months. Require the use by the Lodge of the Uniform Chart of Accounts provided for in the Laws of the Order.

Americanism Committee: This Committee is charged with implementing the patriotic activities of the Order and its Subordinate Lodges. The Committee should encourage the Lodge to participate in as many of these programs as possible in order to accomplish a diversified impact for Americanism in their area.

Bulletin Editor: Prepare the newsletter for publication. Prepare mailing

Community Activities: This Committee shall have general charge and supervision of all matters pertaining to Elks Activities of civic, social and community interest, excepting those allotted to other committees. Plan Community projects emphasizing charitable works of the Order.

Drug Awareness: Promote our Drug awareness program through Red Ribbon day, Drug Awareness contest with area schools and create awareness in the community.

Elks Memorial Day Committee: Laws of the Order mandates Lodge observance on the first Sunday in December in memory of departed Members. This Committee is charged with organizing and promoting this event. It should be open to the public with special invitations to relatives of the Members it honors.

Elks National Foundation: This Committee has as its primary duty, publicize the Elks National Foundation, to promote its programs, activities and charities, to encourage and solicit contributions, and to appropriately recognize all gifts made to the Foundation. This Committee shall have no jurisdiction over the scholarship contest or other activities sponsored by the Foundation.

Flag Day Committee: This Committee is responsible for conducting the Flag Day Service mandated by the Laws of the Order.

Government Relations Committee: This Committee is charged with implementing the Government Relations Programs of the Grand Lodge and State Association.

Lodge Activities: This Committee is responsible for executing the programs of the Grand Lodge, State Association and Lodge that are not specifically assigned elsewhere; to plan and execute social functions in our Club Room. The goal of this Committee should be winning the All-American Lodge Award for the Lodge.

Membership Committee: Use such means and employ such

methods as may be best adapted to secure applications for membership in the Order, and to increase the membership of the Lodge.

Indoctrination (Orientation) Committee: This Committee is responsible for acquainting candidates and their families with the history of the Order, its benevolences and rightful place in society.

Investigating (Interview) Committee: This Committee is to carefully examine the character of all applicants for membership; verify their statements made in the applications and report thereon at the next regular meeting of the Lodge.

Lapsation Committee: This Committee is to address the reasons for lapsation and make every effort to retain our existing membership. The Committee also executes a program of reinstating members whose memberships have lapsed. Another important function of this Committee is to consult the list of "Stray Elks" notices sent to all Lodge Secretaries by the Grand Secretary.

Public Relations: This challenging assignment requires knowledge of the news media, ways of attracting their attention and continuing efforts to accomplish favorable results. Committee Members should carefully study the suggestions published in the Grand Lodge Media Relations Manual to promote the Lodge Elksdom activities in the local paper, the Elks State News Letter and the National Magazine. Provide our Lodge Newsletter Editor with information.

Veterans Service Committee: Keep the Lodge informed of the needs of our hospitalized and homeless Veterans. Promote volunteerism at the Boulder City Veterans Home. It is the duty of the Committee submit the Veterans Remembrance Report and quarterly reports to the State Association. The **Adopt-A-Veteran** and **Army of Hope** programs are also the responsibility of this Committee.

Elks Training Committee: This Committee is responsible for providing the Members with the opportunity to become more knowledgeable in the Laws of the Order and the Subordinate Lodge, the State Association and the Grand Lodge.

Visiting Committee: This Committee is charged with visiting Lodge Members within its jurisdiction that are ill and report its activities at each applicable Lodge meeting.

Youth Activities: This Committee shall prepare, supervise and conduct all Elks programs on behalf of the youth of the community, and shall have charge, supervision and responsibility for all youth programs of the Lodge, and all such matters as shall be referred to the Lodge by its State Association or the Grand Lodge Youth Activities Committee. Promote Youth activities week, plan and execute children's parties.

The **Drug Awareness, Hoop Shoot, Soccer Shoot, Scouting and Scholarship Programs** are the responsibility of this Committee with each being a structured as a separate Committee.

Recipe of the Month
Buttermilk Oven Fried Chicken


Ingredients

- 12 cups Corn Flake, Crushed*
- 1 large heads of garlic, peeled and lightly crushed
- 3 teaspoons paprika
- 3 teaspoons cayenne pepper
- 3 teaspoons dried herbs (thyme, oregano, basil, or a combination)
- 2-1/2 teaspoons salt
- 1 pounds unsalted butter
- 2 quarts buttermilk
- 15 pieces legs, with skin
- 15 pieces thighs, with skin
- 15 pieces breast, with skin

Preparation

* Crush but do not pulverize the corn flakes.

1. Pour buttermilk, garlic, salt, pepper, paprika and cayenne into large container. Rinse chicken and pat dry with paper towels, then transfer to the container with the other ingredients. Cover, and refrigerate overnight, turning once.
2. Position two oven racks evenly spaced so that air can circulate. Heat oven to 400 degrees. Line two baking sheets with foil and coat with nonstick spray.
3. Place crushed Corn Flake in a shallow dish and season with salt and freshly ground black pepper. Remove chicken from buttermilk mixture, letting excess drip off, and place in Corn Flake Crumbs, turning to coat completely and pressing crumbs onto chicken.
4. Place a small amount of the crushed Corn Flake on the baking sheets.
5. Using tongs transfer to the foil lined baking sheet and repeat with remaining chicken. Gently shake enough crumbs out of the bag to coat the tops of the pieces. Drizzle melted butter over chicken pieces.
6. Bake until golden brown and crispy and internal temperature is 160 degrees, about 45-60 minutes for pieces with bone, or until juices run clear. (Larger pieces and dark meat take the most time to cook.)
7. Serves 30 people


